INFORMATION TO COMPLETE YOUR BEQUEST

Making a bequest to ANAM is a simple process. If you are in the process of writing or rewriting your Will, suggested wording is below:

A BEQUEST OF AN ABSOLUTE SUM

I give to **THE AUSTRALIAN NATIONAL ACADEMY OF MUSIC**, [ABN 18 067 405 190] free of all duties the sum of **[amount in words] DOLLARS (\$X)** and I DECLARE that the receipt of the proper officer for the time being is a sufficient discharge to my Trustees

A BEQUEST OF A PERCENTAGE OF YOUR RESIDUAL ESTATE

I give to THE AUSTRALIAN NATIONAL ACADEMY OF MUSIC, (ABN 18 067 405 190, free of all duties [in words] per cent of my residual estate and I DECLARE that the receipt of the proper officer for the time being is a sufficient discharge to my Trustees

NAMED SCHOLARSHIPS, BEQUESTS TO SPECIFIC PROGRAMS or LEGACY ITEMS

If there are specific programs that you would like to support at ANAM, such as a scholarship in memory of a loved one for example, we would welcome the opportunity to discuss your wishes and where your gift will have the most meaningful impact.

If at any time and for whatever reason it becomes impracticable or impossible for The Australian National Academy of Music to continue to apply the bequest for the purpose or purposes directed by me in this my Will then the Board of The Australian National Academy of Music may apply the bequest for such other purpose or purposes the Board determines are most closely in accordance with my directions.
